7 Policy Statement:

- 8 In order to ensure a more transparent, effective and accountable government, the
- 9 City of Sacramento (City) shall make information available online using open data
- standards while complying with applicable law and adhering to City policies andprocedures.
- 12 This Open Data Policy is intended to improve the internal management of
- 13 information controlled by the City and it is not intended to, and does not,
- 14 create any right or benefit, substantive or procedural, enforceable at law or in
- equity, by a party against the City, its departments, divisions, its officers,
- 16 employees, or agents.
- 17 Nothing in this Data Policy alters, or impedes the ability to carry out, the
- 18 authority of the City to perform responsibilities under the law and consistent
- 19 with applicable legal authorities, appropriations, and City Manager guidance,
- nor does this Data Policy limit the protection afforded any information by other
 provisions of law.

1 Applicability

- 2 This policy and procedure applies to all City data presented to the public via the
- 3 City of Sacramento's open data portal at <u>www.data.cityofsacramento.org</u>.

5 Responsibility

6 City Clerk

- 7 As the City's official record keeper, the City Clerk or designee (Records
- 8 Manager) will confer with appropriate stakeholders and the City Attorney, as
- 9 appropriate, before approving data sets for delivery through the City's Open
- 10 Data Portal. All data sets accessed through the open data portals are confined
- 11 to public information and **must not** contain any protected data as defined
- 12 herein.
- 13 If the city is notified that data on this data portal is factually inaccurate or
- misleading, or is protected data, the Records Manager shall as appropriate,
- promptly correct or remove such data from the City's data portal.

16 Primary Data Custodian

- Requests for delivery of City data sets via the City's Open Data Portal shall
 be submitted to the City's Records Manager as designated by the City Clerk
 for vetting and approval.

21 Enforcement

- Any data sets appearing on the City's Open Data Portal that are not
- approved by the City's Records Manager will be removed until the data is
 properly vetted.

Open Data Policy-Procedure -Terms of Use

SACRAMENTO

- For purposes of identifying data sets for inclusion on the Open Data Portal,
 each department shall consider whether the information embodied in the
 data set:
 - is identified in the City's Record Retention Schedule;
- 5 > is appropriate for public release;
- is frequently the subject of a written request for public records of the
 type that a public body is required to make available for inspection or
 copying under California Public Records Act;
- 9 > increases accountability, efficiency, responsiveness or delivery of
 10 services;
- 11 > improves public knowledge of the City and its operations;
- 12 > furthers the City's mission;
- 13 > creates economic opportunity; and
- All departments shall make reasonable and appropriate efforts to update its
 public data on a regular basis to the extent that the City regularly maintains or
 updates its data sets.

19 Open Data Coordinator

- 20 Each department director shall designate an Open Data coordinator to assist
- 21 the department in implementing the City's Open Data Policy, which includes;

OPEN DATA TERMS OF USE





1 Introduction

2 The City of Sacramento, California (the "City") will make a variety of publicly available data sets (the "Data"), which are provided for informational purposes 3 only and made available for download through the City of Sacramento, California 4 5 website (data.cityofsacramento.org). The City grants any interested user (the 6 "User") access to and use of the Data subject to the City's Open Data Terms of 7 Use (the "Terms") and applicable laws. The Terms, constituting a binding agreement between the City and the User, govern and control the User's right to 8 9 access and use the Data, including any Derivative Work.

11 Acceptance

- The User must accept and agree to the Terms in order to access and use the Data. The User accepts and agrees to the Terms by machine-consuming, or downloading and using the Data, which signifies the User's express or implicit acceptance of the Terms at that point in time.
- 16 The User represents that he/she has the legal capacity and authority to accept 17 the Terms. If the User accepts the Terms on behalf of a third party (for 18 example, another individual, an employer, or entity), the User represents and 19 warrants that he/she has the legal capacity and due authority to act on behalf of 20 the third party and obligate the third party and himself/herself to comply with 21 the Terms.
- The User acknowledges and agrees that there may be additional terms and conditions that are embedded or otherwise stated in any file, containing the Data, or on the page from which the Data is accessed, which the User accesses and uses; those terms and conditions will be considered a part of the Terms, as they are deemed incorporated in the Terms.

5 Indemnity

To the full extent permitted by law, the User will indemnify, defend at his/her 6 sole cost and expense, and hold harmless the City, its officials, officers, and 7 employees from and against any claim, injury, liability, loss or damage of any 8 kind, nature and description (including, without limitation, incidental and 9 consequential damages, court cost, attorney's fees and costs of investigation), 10 that may arise, directly or indirectly, in whole or in part, from the User's 11 download of and use of the Data, including the Derivative Work. The User's 12 obligation to indemnify, defend and hold harmless the City arises, even if the 13 claim may be groundless, false or fraudulent; the obligation will arise at the time 14 the City tenders the claim to the User and continues at all times thereafter. 15

17 Miscellaneous Provisions

The Terms represent the entire understanding and agreement regarding theUser's access and use of the Data, including the Derivative Work.

The Terms are governed by and interpreted by the laws of the State of California
without regard to any of its conflict of law's provisions.

Any dispute regarding the Terms will be resolved and settled by informal mediation or, if mediation should fail, by litigation. Any action at law or in equity will be commenced in a federal or state court located in the County of Sacramento, California; the User and the City consent to the venue and jurisdiction of such courts when the User expressly or impliedly accepts the Terms.
